## THE 2020 MEMORANDUM OF UNDERSTANDING

Representing the collaborative will of all the schools sectors, the Council is delighted to announce the endorsement of the 2020 Memorandum of Understanding (MoU). This is a tangible milestone in exemplifying the strength of relationships between the various school systems.

The 2020 MoU commits the Department of Education and Training (the Department), the Catholic Education Commission of Victoria (CECV), and Independent Schools Victoria (ISV) to continuing to work in a strategic partnership to enhance the educational outcomes of all Victorians. This MoU is a commitment to supporting the work of the 2018-2021 Funding Agreement and to the development of a new MoU from 2021.

## 2019 HIGHLIGHTS AND ACHIEVEMENTS

The Council was pleased to announce the following highlights from the work this year;

- The Koorie Education working group exploring exemplary curriculum work that developed links to local Aboriginal perspectives. This follows greater sharing of resources across the sectors, especially the Cultural Understanding and Safety Training modules which can have whole of school impact.
- The work towards building the cross-sectoral event 'Student Leaders for Multicultural Inclusion State-wide Forum' which will take place in Term 1, 2020. The State-wide Forum will strengthen student leadership, cross-sectoral collaboration and sharing of good practice.
- The inaugural meeting of the Cross-sectoral Professional Leadership Forum, bringing greater collaboration between sectors on leadership development. This is further supported by scholarships to key leadership forums.

Council also wishes to acknowledge the hard work and care of rural and regional school communities to continue to build cross-sector partnerships. Council will continue to work in 2020 to support further initiatives to build stronger links across the sectors.
